ATV Maine also has 2 other bill in for the ATV registration increase and that money will all go to DACF for trail grant and the other is for an definition of ATV's & UTV's.

Free Weekend will be August  $16^{th}$ ,  $17^{th}$ , and  $18^{th}$  will be the free ATV'ing weekend in 2019. The ATV's must be registered from where they live.

**Old Business:** Liability insurance is going to change so that it runs with the membership year. Present policy will be canceled on June 30 and restarted on July 1. Then, as of July 1, 2019, the liability insurance policy will run with the ATV Maine membership year, July 1st through June 30th.

The AD&D insurance has been brought back for all ATV Maine clubs and club members. The AD&D insurance was restarted on November 4, 2018. Tami is still working with Shane on the members.

**New Business:** The D&O insurance will change because it was cheaper, bringing the cost down from \$900.00 to \$558.00.

**DACF – ATV Definition:** The proposed change covers ATVs/UTV's up to 65 inches. Dual registration of vehicles for street and trail will not be allowed. Landowner restriction would be covered. Motorcycles are defined separately.

A Recreational Trail Program [RTP] bill is being put in federally to increase the amount of money going into the RTP fund from the gas tax with better documentation.

**Break:** 1035 – 1051.

**Northern Region Report:** Bypass trail in Presque Isle is open for snowmobiles this winter. It will be open for ATV's next summer.

Western Region Report: Roxbury has a new trail master.
