Make available ATV-related literature to any affiliated club and participate in area sport shows and events to positively promote the sport.

To Provide REPRESENTATION in Government, Local, State and Federal.

Be a unified voice in legislative issues regarding ATV use.

Provide representation in policymaking decisions on ATV issues.

Hold representative positions on government advisory committees.

To OPEN UP LANDS for more trails to ride on.

Encourage affiliated clubs to help educate landowners, law enforcement & local government on the benefits of having a maintained ATV trail system.



#### Secretaries Report:

Secretary's report is unavailable, at this time.

#### **Treasurer's Report:**

Sue Lanouette states that she has transferred 25000. Between accounts. Kept the General Checking account and also the Liability insurance account. Canceled the Pot of Gold account and the Trailer Account.

Real states that we have discussed transferring the money between the accounts to accrue interest on the monies that are already available. The other two accounts are no longer necessary to have so ATV Maine officers agreed to close them.



#### **Presidents Report:**

Real Deschaine requests a moment of silence for Phil Flag, who passed away last month.

The contract has been signed with Ed Pineau of Policy Associates LLC to continue to be our lobbyist. He will attend when the bills are back in session.

Real states that his daughter Kendra Deschaine is the internal accountant for the company Matrix. Matrix has a program called Matrix Gives that has chosen to donate \$1000 to ATV Maine in memory of Anne Deschaine.

Real Deschaine received an email from the Landowner Sportsman Relations Advisory Board. They will be hosting a meeting Monday December 14, 2020 at 6:00 pm. The meeting will be held virtually.

Real is recommended that John Raymond be on the open seat of the Maine Trail Advisory Board. There is a lot of funding information on this board for RTP grants. It would be good to have something on the board.

At the October meeting we discussed purchasing game cameras for the ATV Clubs. Sue has been in contact with Cabela's and was able to get two cameras for the price of one for each club. Cabela's will donate \$250 towards the purchase since ATV Maine is a 501-C3. John Raymond states we are doing this for the clubs, and also to boost landowner relations.

#### Vice Presidents Report:

Trails are closed in the area, we could have kept them open longer but there was some damage done to two bridges. A pick up went over one and destroyed it and a dump truck went through the other. Going to have to fix both of them.

John stated that Kenny was able to get the connection from East Millinocket to Matawamkeag.

John states that he spoke to P&C about looking to purchase land. We have made an offer and are waiting on the counter offer.

Discussion on upcoming trade shows that ATV Maine plans on attending. Trade shows are canceled for the 2021 season. ATV Maine plans on attending both the Augusta and Orono shows in 2022. We plan on creating an event at the Cross Center in 2023. This will take a few years to plan. John states that he will donate the display stand. We have discussed making a banner with all of ATV Maine's current Club's logos on it. This can promote ATV Maine and generate a huge cash flow.



#### **Northern VP Report:**

Most of the trails are closed in their club. This year they have received more complaints than they ever have. A lot more AT-V's and SXS are being purchased which means more people out on the trail system. Dick states that he ended up having to put cameras out which led to someone getting caught damaging the trails and was fined for it.

Aroostook County will be updating the trail map this year. Professor Wong will be working on the updates for the map. We are extremely fortunate for having him do them. He has done an amazing job for us.

Real states that the professor does great work!

#### **Eastern VP Report:**

Some of the trails are closed down in our area, not all of them yet though.

Damage has been done to one of their trails also, the trail was shut down with \$5000. In damages.

Daryl states the Newsletter deadline is January 10, 2020.

John Raymond states that last year ATV Maine decided to pay Kendra Deschaine to assist in a full audit. Paying her \$12 an hour up to 10 hours per week at \$120 a week. In the E-Board meeting we agreed to pay Kendra until January 1, 2021 to finish up. After January 1, 2020 Kendra will go back to a stipend.

Ronnie Green made the motion to have Kendra's pay switched back to stipend after January 1, 2020 since the audit is complete. Daryl Friedman seconded the motion. Passed by all Directors.

Real states that the reason a full audit was done was because someone questioned where the money was going.
