**Penobscot Ridge Riders ATV Club / Article III**

1. Initial Members: Members in PRR shall consist initially of the incorporates whose signatures appear on certificates of organization.
2. Membership is open to any person of good character and in sympathy with the purpose of PRR upon application to the Secretary & payment of your 1 year dues.
3. Membership shall consist of 3 classes:
  - A. Family memberships shall include Husband / Wife & their children under age of 18.
  - B. Individual members.
  - C. Associates shall belong to another Club.
4. Powers: Members ( 18 and older ) shall be eligible to vote at meetings and hold office in PRR.
5. Resignation / Removal: If a member, while operating ATV / UTV violates any law or regulation or commits any act which could reflect on the integrity of PRR, their membership may be terminated by a majority vote of the Board of Directors or if annual dues remain unpaid 60 days after bills are mailed out by Treasurer.
