Airline ATV Riders Meeting Minutes October 19 & November 16, 2023

Opening:

The regular meeting of the Airline ATV Riders was called to order at 7:05 & 7:04 pm on Oct. 19, & Nov. 16, 2023, by Jim Butler.

General Greeting:

Pledge of Allegiance was said. Welcomed new members.

Treasurers Report:

Pam reported that in Oct. Savings had \$10,926.29 Checking had \$541.54, Total in the BFCU was \$11,467.83, in Nov. Savings has \$10,482.75 Checking has \$264.29, Total for Nov. is \$10,747.04 Accepted as read by all members present.

Secretary's Report:

There was no meeting in September due to most attending the Celebration of life for Paul Gargan who passed. Minutes for Oct. read at meeting accepted by all members present.

Membership Report:

110 primary members, 9 associate members and 17 business memberships. Currently 120 members and 17 business members.

Presidents Report:

Covered in old and new business

VP Report: Absent this meeting. Notes read by Garnet:

- 1. We received our municipal grant money of \$7,587.58 for the trail work we have done so far this year. We could not get the rest of our funding due to the state not sending us a copy of the approval letter. So the remaining projects will be added to next year's list.
- 2. Discussed having a pot-luck dinner with a yankee swap in December.
- 3. We need a Business Membership Coordinator for our club.
- 4. Our yearly club picnic was attended by about 35 people. Jacqueline wanted to express her thanks to everyone helpers to people that brought food to share.
- 1. **A)** I made the final grant submission for the 2023 season. It consisted of mile age and labor hours. The submission was for \$4,675.13. We expect to get 90% of this amount (\$4,207.62)
 - **B)** Thank you to everyone who worked on our trails this year.



Chairperson Report from the Board of Directors from Loren Braley.

- 1. Update on the club's new website. It is now live and we have had over 700 people look at it and our first membership received through it.
- 2. We appointed Pam Braley as our permanent treasurer. She will hold the position till our officers voting session in 2025 or when someone steps up that is qualified to take the position. She is spread pretty thin with her other club duties.
- 3. In the spring we will be looking for at least two BOD members. Peter Grant has resigned from the board, and Cheryl Friedman would like to as well but will remain if no one else steps up into the position.
- 4. Talked about adding a co-trail master or a trails committee. The job is extensive and travel time and health of our current trail master was consideration for this discussion.
- 1. Discussed the final receipts submitted for reimbursement for the Municipal Grant.
- 2. A final bill for \$212.16 needs to be paid to Pro-Found for our website. This will be a recurring yearly bill for our domain name and webhosting services. Cheryl motioned and Garnet 2nd. Passed by BOD members present. We need to have some 5 star reviews to be posted on the site. Stephanie still has to work on the video for the site and will let us know when it's done.
- 3. Daryl has been working on a new reference map for our website. Also has been learning the ins and outs of the site, has already made a couple changes to our calendar. If anyone else would like to learn to update the site let him know and he will train them.
- 4. In March 2024 elections we will be voting for 3 BOD members. Cheryl is willing to stay unless someone else would like to step up. Also both Peter Grant and Jim Hester have expressed they do not want to continue on the BOD. Looking for members to step up into these positions.
- 5. The date for the club Christmas Social has been set for Sunday Dec. 17, 2-6 pm.
- 6. Should we attend the ATV Maine 1st annual ATV/UTV Expo in May of 2024. The cost is \$475.00 for a booth. This will be discussed in the regular meeting.
- 7. Garnet mentioned we should continue with a trail committee to help with assigning sections of trails to people interested in helping maintain and schedule work sessions and after storm clean up crews. We need to locate the rest of the equipment and tv that belongs to the club and put in the club trailer.



ATV Maine:

- 1. Hosted a DEP training class on August 10th and October 26th. Everyone that attended the all day class got their certificates. They just have to do their photo's and submit them to be fully certified.
- 2. There will be a regional meeting in Western Maine on Oct. 21. Cheryl will provide a report about this meeting at our final meeting for the season in November. This meeting mostly covered their new event in May 2024 which will feature ATV/UTV's to accessories to clubs from all over the state. Polaris and Nitro trailer are a few vendors of many signing up. - 3. Juno Campbell from American Income Life gave an update on the policy for AD&D next year they are hoping to have an option that if the person/family pay's an extra \$2.00 then the policy limits will go from \$3,500 to \$10,000 for that year.
- 4&5. They had their nominations for officers for 2024 season. They are the same except for needing someone to step into the Secretary and Southern Region VP Positions. The ongoing discussions for the reciprocity agreement with Canada has hit a snag on our side. Our legislature has not even addressed it yet and might not even consider it till next year.

Trail Master's Report:

- 1. Eric Sprague rode our trails with us. We got a good map of our trails and after one or two updates we have 95 miles of trails.
- 2. Part of the 510 is closed for repairs. Also part of the 508 is closed and we are looking at options to have it rerouted.
 - 3. Our last club ride of the season will be on Oct. 29 around the windmills.
- 1. Warren and Jim did a fantastic job of continuing to watch over the trails and replacing signs as needed.
 - 2. If you do ride, please wear blaze orange hunting season is in full swing.
 - 3. The trails will be closed when AFM locks the gates. Signs will be posted.


